As of **July 31, 2006**, we will temporarily relocate our practice operations to Ingram, Texas. All visits and office inquiries will be by previously scheduled appointment only. Unfortunately, we will not be able to accommodate any walk-in patients at that location. We will not be able to provide care for anyone without a previously scheduled appointment for the last two weeks of August after **August 7, 2006**. We will close our Kerr County practice completely on **August 27, 2006**.

Our schedule is already quite full and we may not be able to accommodate all requests for appointments with Dr. Williams before his departure. We may arrange visits with Dr. Williams or help arrange a visit with a covering physician through **August 13, 2006**. After that date, Dr. Williams will no longer be able to provide unscheduled care as he finalizes the close of his practice.
